	4. C-17 ACIQ students must be a USAF/USN trained SUPT/JSUPT graduate. US Army trained fixed-wing pilots and all helicopter pilots who have not completed USAF/USN "primary" training (T-6/T-37/T-34) must complete T-6A Primary Pilot Training (PPT) (P-V4A-J) and T-1A Specialized Undergraduate Pilot Training (JSUPT) (P-V4A-G), T-38C Specialized Undergraduate Pilot Training (SUPT) (P-V4A-A), or T-38C Qualification (F-V5A-T(Q)) before entering this course. International students must have completed USAF/USN "primary" training, or equivalent as determined by 19 AF/DOG.
	5. Security Clearance (minimum of SECRET) Verified in JPAS & valid through class graduation date, or a reinvestigation is open prior to class start date IAW syllabus.
	6. Student has reviewed reporting instructions and has thoroughly read and agreed to abide by all policies in the AAFB Student Handbook located at https://app10-eis.aetcf.af.mil/etca/SitePages/Home.aspx prior to departing for training. (must use CAC email certificates)

	7b. Medical: DD Form 2992 from most recent PHA.
	7c. Flight records: Copy of ARMS IDS & Flying History Report.
	7d. Copy of Altitude Chamber card (showing current for 30 days past grad date).
	7e. Current printout of AFFMSII (Fitness Report). Scored/signed scorecards are acceptable if report is unavailable.
	7f. Copy of this completed checklist signed by Sq/CC or authorized representative (DO, training shop, etc.)
	8. Student will arrive by 0715 on class start date for in-processing at building 87, 1st floor, Student Admin. Doors open at 0700.
