SUBJECT: Hangar 97 Dining Facility Closure Extension

1. On 1 April 2021, the Altus AFB dining facility closed to undergo facility renovations and improvements. This project was due to be complete 187 days from contractor start date. However, the project completion date has extended and the facility is expected to reopen no later than 30 April 2022. Airman residing in unaccompanied housing will be authorized to receive BAS/BAS II during this closure period. All other personnel who are TDY to Altus AFB during the closure will be entitled to full per diem in accordance with the JFTR.

SUBJECT: Temporary Approval of Basic Allowance for Subsistence (BAS) II at Altus Air Force Base, Oklahoma

In accordance with the provisions of 37 USC § 402(d), the DoD Financial Management Regulation 7000.14-R, Volume 7A, Chapter 25, and DoD Directive 1418.05, Paragraph 4.3.7, the Air Force is authorized to implement payment of BAS II to members meeting specific eligibility criteria. The Wing Commander at Altus Air Force Base, OK, has requested temporary approval to pay BAS II to enlisted members occupying unaccompanied government housing for the period of 1 April 2021 to approximately 31 October 2021 while the dining facility is closed for renovation.

Effective 1 April 2021, I approve payment of BAS II to Air Force enlisted members occupying unaccompanied government housing at Altus Air Force Base until the dining facility projected reopening 1 November 2021. I authorize a 90-day extension to 31 January 2022, if required due to delays. Any delay over the 90 days will require the Wing Commander to resubmit a request with the new opening date and an explanation of the delay. Food preparation and storage facilities were determined to be inadequate for extended use during the dining facility closure for renovation. An estimated 270 enlisted members will receive BAS II for this period.
