If they are not uploaded before you graduate from PIQ, you will need to provide a Letter in Lieu of Orders MFR or a PCS RIP directly to our HARM office during out-processing so your flight records can be sent to your new base.</p> <p>4. IAW DAFMAN 36-2139 and the KC-46 ADSC MFR posted on ETCA, USAF Active Duty requires a 3 year ADSC. (N/A for non-prior service airmen) Guard and reserve students follow home unit procedures. This ADSC does not apply to KC-46 aircrew accomplishing requalification training.</p> <p>5.
